What is Outcomes-based Assessment?

Outcomes-based assessment focuses on the ability of the assessor to make judgements about a learner's performance and improve upon it. It makes use of authentic assessment methods and offers opportunities for learners to develop their skills by achieving their goals through specified outcomes.

This workshop meets all the requirements of unit standard 115753: Conduct outcomes-based assessment. (NQF 5, 15 credits)

After each of our workshops, delegates have three months to take the learning back to the workplace, apply it and complete a Portfolio of Evidence (PoE) for assessment. We offer coaching during this important period, guiding learners towards meeting the rigorous requirements of the unit standard.
